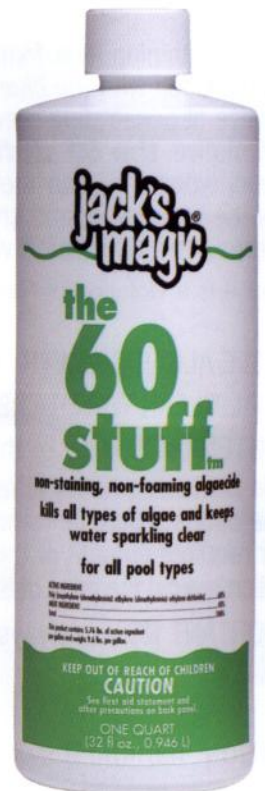

When used in conjunction with *the blue stuff*[®], *the pink stuff*[®], or *the purple stuff*[®], the algae-killing power of **the 60 stuff**[™] is particularly effective at penetrating crevices where tough-to-remove black algae thrives. **the 60 stuff**[™] is also a highly effective algae preventative. **the 60 stuff**[™] treats stubborn algae growths in chlorine, bromine, salt, ionizer, and ozone systems, and is for all pool types. This non-metallic algaecide contains powerful surfactants with wetting agents that allow it to remove algae from the tiny cracks and crevices where algae often starts. **the 60 stuff**[™] works well in pools with attached spas or water features. **the 60 stuff**[™] will not affect pH levels.

DIRECTIONS FOR USE

VISIBLE ALGAE GROWTH: 16 oz. of this product per 10,000 gallons of pool water.

INITIAL CLEAN WATER TREATMENT: 9 oz. of this product per 10,000 gallons of pool water.

MAINTENANCE: 4 oz. of this product per 10,000 gallons of pool water on a weekly basis.

Pools containing heavy algae growth should be cleaned prior to using this product. 24 hours after treating visible algae growth, algae debris should be removed by standard cleaning procedures. Dilute this product with at least 9 parts water before applying. Pour required amount of this product into plastic watering can and fill with water. Maintaining constant pool circulation, sprinkle solution around the edge of the pool.

IMPORTANT NOTE: Always apply chemicals separately. Never combine them.

PRECAUTIONARY STATEMENTS

HAZARDS TO HUMANS AND DOMESTIC ANIMALS

CAUTION: Harmful if swallowed. Avoid breathing vapors. Avoid contact with skin, eyes, or clothing.

FIRST AID

IF IN EYES:

Hold eye open; rinse slowly and gently for 15-20 minutes. Remove contact lenses, if present, after the first 5 minutes, then continue rinsing eye. Call poison control or a doctor for treatment advice.

IF ON SKIN:

Take off contaminated clothing. Rinse skin immediately with plenty of water for 15-20 minutes. Call poison control or a doctor for treatment advice.

IF SWALLOWED:

Call poison control or a doctor immediately for treatment advice. Have person sip a glass of water, if able to swallow. Do not induce vomiting, unless told to do so by a doctor or poison control. Do not give anything by mouth to an unconscious person.

IF INHALED:

Move person to fresh air. If the person is not breathing, call 911 or an ambulance, then give artificial respiration, preferably mouth-to-mouth. Call poison control or a doctor for treatment advice.

NOTE TO PHYSICIAN

Probable mucosal damage may contraindicate the use of gastric lavage.

ENVIRONMENTAL HAZARDS

This pesticide is toxic to fish. Keep out of lakes, streams or ponds. Permits may be required for discharges containing this pesticide into lakes, streams, ponds or public water. For guidance contact the regional office of the Environmental Protection Agency
